- 3. The indemnity bond should be on Rs. 100/- non judicial stamp paper and affidavit on Rs. 10/- non judicial stamp paper and should be verified by a first class magistrate or oath commissioner or notarized with appropriate value of notaial stamp.
- 4. The name, signature and address of the sureties should be required on the Indemnity bond and also attach their photo ID proof having their address.
- 5. Each & every page of the indemnity bond & affidavit must be signed by the legal heir(s).
- 6. If shares value is more than Rs 10,000/- then an advertisement of the lost share certificates has to be given in newspaper (where registered office of the company is situated) furnishing the details of lost shares in English language.
- 7. Self attested copy of Aadhar card or voter ID or passport in respect of address of registered with us.
- 8. Specimen signature and color photograph of the one/all legal heir(s) duly attested by bank manager in enclosed Performa.
- 9. Original Cancelled Cheque with name of first legal heir printed on it OR copy of passbook or bank statement attested by banker alongwith cancelled cheque.
- 10. Self certified copy pan card of legal heir.
