On Induction

- Along with the appointment letter, they are furnished a copy of the Schedule IV to the Companies Act, 2013 which contains guidelines for professional conduct, role and functions, duties, etc. together with a summary of the relevant provisions of the SEBI (Listing Obligations & Disclosure Requirements), 2015.
- A copy of the Code of Conduct for the Directors is also shared with them for information and adherence.

Continual updates

- At the Board meetings, information about operations, project updates, legal updates, CSR and sustainability related matters, changes in the regulatory scenario, Business Risk related issues, update on compliances and other relevant details are presented to the Board.
